#### Item 8.01. Other Events.

On February 13, 2020, Oaktree Specialty Lending Corporation (the "Company") notified Deutsche Bank Trust Company Americas, the trustee (the "Trustee") for the Company's 6.125% Unsecured Notes due 2028 (the "Notes"), of the Company's election to redeem the \$86,250,000 aggregate principal amount of the Notes outstanding, and instructed the Trustee to provide notice of such redemption to the holders of the Notes in accordance with the terms of the indenture governing the Notes. The Company expects the redemption to be completed on March 13, 2020. Following the redemption, none of the Notes will remain outstanding, and they will be delisted from the Nasdaq Stock Market LLC. This Current Report on Form 8-K does not constitute a notice of redemption of the Notes.

On February 13, 2020, the Company issued a press release that announced the redemption of the Notes. A copy of the press release is furnished as Exhibit 99.1 to this report on Form 8-K and is incorporated herein by reference.

### Oaktree Specialty Lending Corporation to Redeem 6.125% Notes Due 2028

LOS ANGELES, CA, February 13, 2020 – Oaktree Specialty Lending Corporation (NASDAQ: OCSL) ("Oaktree Specialty Lending" or the "Company"), a specialty finance company, today announced that it will redeem its 6.125% Notes due 2028 (NASDAQ: OCSLL) (the "Notes"). The Company will redeem 100%, or \$86,250,000 aggregate principal amount, of the issued and outstanding Notes on March 13, 2020 (the "Redemption Date"), following which they will be delisted from the Nasdaq Stock Market LLC. The redemption price per Note will be \$25 plus accrued and unpaid interest to, but not including, the Redemption Date.
