

## Tax Character of Distributions for 2018

The tax character of distributions from Oaktree Specialty Lending Corporation (the "Company") for calendar year 2018 is set forth below. For tax purposes, the Company is a regulated investment company ("RIC") and designates the tax character of distributions you received for calendar year 2018 in accordance with Subchapter M of the Internal Revenue Code of 1986, as amended.

The amounts shown in the table below represent the accounting of the Company's 2018 distributions. This information supersedes any estimated information you may have received during the year.

Distributions that were reinvested through the Company's Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participate in the Dividend Reinvestment Plan should also refer to the above table.
